

## STANDARD & BENCHMARKING IN SCHOOL EXCELLENCE

- ✓ the implications for the New Education Policy 2020,

### **Extracts of NEP 2020 - Continuous Professional Development (CPD)**

5.15. Teachers will be given continuous opportunities for self-improvement and to learn the latest innovations and advances in their professions. These will be offered in multiple modes, including in the form of local, regional, state, national, and international workshops as well as online teacher development modules. Platforms (especially online platforms) will be developed so that teachers may share ideas and best practices. Each teacher will be expected to participate in at least 50 hours of CPD opportunities every year for their own professional development, driven by their own interests. CPD opportunities will, in particular, systematically cover the latest pedagogies regarding foundational literacy and numeracy, formative and adaptive assessment of learning outcomes, competency-based learning, and related pedagogies, such as experiential learning, arts-integrated, sports-integrated, and storytelling-based approaches, etc.

The webinar series will be held on selected days across five successive weeks, making FIVE webinars in the sequence, each webinar lasting approximately 3 to 4 hours per day. Every webinar is a certified course and every educator is assessed after the program.

### **The program and subjects covered will be:**

#### **Day 1. Why do School Leaders need to understand standards and bench-marking for school excellence?**

**Introduction - standards and bench-marking for school excellence.** Giving a greater understanding of the positive role that external and internal validation of schools and educational institutions can play in improving school performance, standing and reputation.

**Leadership and management, the effectiveness of the school's leadership and management.** What is the impact of the leaders and managers in your school? What are the skills, behaviors and capabilities of school leaders, owners, managers, can enhance school performance and the achievements of their students.

**Curriculum – quality, breadth and balance.** Few would doubt that the curriculum is an essential part of school life. Without this a building full of teachers, leaders and pupils is not a school. Yet there has been a lack of reflection on the design, content and implementation of curriculums in recent years. This session focuses on the greater understanding of how the curriculum underpins learning and drives the success of a school and its students.

## Day 2. How do we care for our students?

**Spiritual, moral, social and cultural development.** Considers how to monitor and measure the school's impact on student's personal development and how the student can derive meaning, purpose, and direction in their life.

**Welfare, health and safety.** Covers the measures to promote the welfare, health and safety of the students, including child protection with respect to regulatory and cultural requirements. The importance of a health and safety policy, and the greater importance of good practice.

## Day 3. How do we manage resources?

**Suitability of proprietor and staff.** As part of safeguarding students and ensuring their welfare and safety we look at Staff recruitment – safety and excellence. Explores ways of making sure the staff appointed to schools are appropriate and how police and other checks can help to keep students safe.

**Premises, resources and accommodation.** The adequacy of the premises and the educational accommodation for securing the health and safety of all students. The suitability of the accommodation for effective teaching and learning for all students. What to look for when you are monitoring the primary learning environment.

## Day 4. How do we measure and inform on the progress and attainment of learners?

**The quality of learning, teaching and assessment.** Looking at the measurement/attainment of learning and how this supports the successful development of learning and teaching in the institution and for the individual student.

**The provision of information for parents, careers and others.** Judging the quality of the school's interaction with and information for parents and careers. This will include the use of MIS and Data Analytical tools.

## Day 5. What have we learnt?

### **Covid 19 effect on schools - virtual and personalized learning**

How will students learning process will be different? How can educators engage with students? Can technology alone develop relevant skills?

### **What is school excellence?**

Closing review session, what we have learnt, what we can take away.
